

Attachment 8: Interfaces

This attachment addresses interfaces and information exchanges that will be required of the Guam Supreme/ Superior Court's new CMS/ERP system. It only addresses external interfaces, as data sharing between the system components (Supreme Court CMS, Superior Court CMS, E-filing System, ERP System, and Jury Management System) is covered elsewhere.

The Supreme/ Superior Court CMS will share data with several external agencies:

- Attorney General's Office
- Public Defender/Alternate Public Defender (APD)
- Police Department
- Department of Corrections
- Department of Motor Vehicles
- Department of Health and Social Services, Office of Vital Statistics
- National Crime Information Center (NCIC)

Information sharing between the Supreme/ Superior Court and these agencies will be accomplished through National Information Exchange Model (NIEM)-based XML exchanges through the CJIS Exchange Broker. The CMS/ERP must interface with the CJIS Exchange Broker. For each exchange in which the Supreme/ Superior Court is the sending agency, the CMS/ERP must serve up the document in XML format to the CJIS Exchange Broker. For each exchange in which the Supreme/ Superior Court is the receiving agency, the CMS/ERP must be able to accept and manage the data.

Specific information exchanges to be implemented are listed in the table below.
